# **ORGANISING AUTHORITY**

The regatta Organizing Authority is the Bermuda International One Design Class Association (BIODCA); with the endorsement of the International One Design Class World Class Association.

# SAILING INSTRUCTIONS (SIs)

The notation '[DP]' means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification. The notation '[NP]' means Rules that are not grounds for protest by a boat (This changes rule 60.1(a)).

# 1. RULES

- 1.1. The series will be governed by the 'rules' as defined in *The Racing Rules of Sailing (RRS)*.
- 1.2. The International One Design World Class Rules and Championship Regulations (which may be found at <u>www.iodwca.org</u>) shall apply. In the event of conflict, the IODWCA Championship Regulations shall take precedence. This changes RRS 63.7.
- 1.3. The Bermuda Sailing Association National Prescriptions and Code of Conduct shall apply and may be found at www.sailing.bm.
- 1.4. If there is a conflict between the NoR and these SIs, the rules in these SIs will take precedence. This changes RRS 63.7.

# 2. NOTICES TO COMPETITORS

- 2.1. Notices to competitors will be posted on the official notice board located at <a href="http://iodwca.org/bermudaworlds2021/race-documents/">http://iodwca.org/bermudaworlds2021/race-documents/</a>.
- 2.2. As a courtesy to competitors, a WhatsApp Group will be used to alert competitors of official noticeboard changes. Competitors are encouraged to join this group - <u>https://chat.whatsapp.com/DeetZirF9AeESklimNYxBI</u>.
- 2.3. On the water, the Race Committee (RC) intends to monitor and communicate with competitors on VHF radio channel 73.

# 3. CHANGES TO SAILING INSTRUCTIONS

Any change to the SI will be posted before 0830 on the day it will take effect, except that any change to the schedule of races will be posted by end of protest time limit on the day before it will take effect.

# 4. CODE OF CONDUCT

- 4.1. [DP] Competitors and support persons shall comply with reasonable requests from event officials. Failure to comply may be misconduct. Reasonable actions by event officials to implement COVID-19 guidance protocols or legislation, even if they later prove to be unnecessary, are not improper actions or omissions.
- 4.2. [DP] Competitors and support persons shall handle any equipment provided by the OA with care, seamanship, and in accordance with any instructions for its use. Attention is drawn to IODWCA Championship Regulation 6.4(d).

# 5. SIGNALS MADE ASHORE

- 5.1. Signals made ashore will be displayed on the right yard-arm of the RBYC flagpole facing the water.
- 5.2. Flag AP displayed with one sound means: '1 minute' is replaced with 'not less than 60 minutes' in the race signal AP.
- 5.3. Flag G displayed indicates racing will be in the Great Sound. Flag P displayed indicates racing will be in Port Royal Bay.

6.1. To alert boats that a race will begin soon, an orange flag defining the starboard end of the starting line will be displayed with one sound five minutes before a warning signal is displayed.

# 7. CLASS FLAGS

Class flag will be:

#### 8. RACING AREAS

The racing areas will be in the Great Sound or Port Royal Bay as detailed in Attachment #1.

## 9. THE COURSES

- 9.1. Attachment #2 shows the courses, including the approximate angles between legs, the order in which marks are to be passed, and the side on which each mark is to be left.
- 9.2. No later than the warning signal, the RC Signal Boat will display the course number, and the approximate compass bearing from the starting line to Mark 1.
- 9.3. A leeward gate (two rounding marks) will be used. Boats shall sail between the gate marks from the direction of the previous mark and round either gate mark. If only one gate mark is set, boats shall round the single mark to port. The gate may be laid after the starting signal.
- 9.4. A windward offset mark will be used. The offset mark may be laid after the starting signal but shall not be used when a course change (SI 13) has been signaled.

#### 10. MARKS

Rounding marks shall be yellow tetrahedron marks (ITB). The offset mark shall be a green ITB. New marks, as provided in SI 13 will be red ITB.

# **11. AREAS THAT ARE OBSTRUCTIONS**

There are no areas in the intended racing areas that are defined as obstructions.

#### 12. THE START

- 12.1. Races will be started by using RRS 26.
- 12.2. The starting line will be between a staff displaying an orange flag on the RC Signal Boat at the starboard end and the course side of the port end starting mark.
- 12.3. [NP] When Code Flag "W" is displayed with the warning signal, it will mean that spinnakers shall not be hoisted for that class during that race.
- 12.4. If any part of a boat's hull is on the course side of the starting line at her starting signal and she is identified, the RC will attempt to hail her sail number. Failure to hail her number, failure of her to hear such a hail, or the order in which boats are hailed will not be grounds for a redress for request. This changes RRS 62.1(a).
- 12.5. A boat that does not start within 4 minutes after her starting signal will be scored DNS without a hearing. This changes RRS A5.1 and A5.2.

## 13. CHANGE OF THE NEXT LEG OF THE COURSE

- 13.1. To change the next leg of the course, the RC will lay a new mark (or move the finishing line) and remove the original mark as soon as practicable. When in a subsequent change a new mark is replaced, it will be replaced by an original mark.
- 13.2. Minor mark moves (up to approximately 100m) may be made without signaling the change. This changes RRS 33.

## 14. THE FINISH

- 14.1. When finishing to leeward the finish line will be between a staff displaying a blue flag on the RC Signal Boat at the port end and the course side of the starboard-end finishing mark.
- 14.2. When finishing to windward the finish line will be between a staff displaying a blue or yellow RC flag on a RC vessel at the starboard-end and the course side of the port-end finishing mark.

#### **15. PENALTY SYSTEM**

- 15.1. The first two sentences of rule 44.1 are changed to: 'A boat may take a One-Turn Penalty when she may have broken one or more rules of Part 2 or rule 31 in an incident while racing. However, when she may have broken one or more rules of Part 2 while in the zone around a mark other than a starting mark, her penalty shall be a Two-Turns Penalty.
- 15.2. [NP][DP] A boat that has taken a penalty under rule 44.1 shall complete a penalty acknowledgement form available on the official noticeboard before the end of the protest time limit.

## **16. TIME LIMITS AND TARGET TIMES**

- 16.1. All times will be taken from GPS.
- 16.2. Time limits for each race shall be 150 minutes. If no boat has passed Mark 1 within 30 minutes the race will be abandoned.
- 16.3. The target time for each race shall be 60 minutes. Failure to meet the target time will not be grounds for redress. This changes RRS 62.1(a).
- 16.4. Boats failing to finish within 30 minutes after the first boat sails the course and finishes will be scored Did Not Finish without a hearing. This changes RRS 35, A4 and A5.

#### **17. HEARING REQUESTS**

- 17.1. The protest time limit is 60 minutes after the RC boat docks. The end of protest time limit will be posted on the official noticeboard.
- 17.2. Hearing request forms are available on the official noticeboard.
- 17.3. Notices will be posted no later than 30 minutes after the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. Hearings will be held online. Participants in any hearings (parties, party representatives and witnesses) must have access to a device that has internet accessibility with audio and video capability. Participants must use audio and video to appear before the protest committee unless advised otherwise by the protest committee. See Virtual Hearing Addendum VH to these sailing instructions.
- 17.4. The posting of hearing notices shall be considered notices as required by RRS 61 and 62.2.

#### 18. SCORING

- 18.1. Scoring shall be as described in NoR 10.
- 18.2. Scores shall accrue to the skipper, not the boat.

#### **19. SAFETY REGULATIONS**

19.1. [DP] A boat that retires from a race shall notify the RC at the first reasonable opportunity.

#### 20. REPLACEMENT OF CREW OR EQUIPMENT

- 20.1. [DP] Substitution of competitors is not allowed without prior written approval of the Jury as per IODWCA Championship regulation 5.3.
- 20.2. [DP] Substitution of damaged or lost equipment is not allowed unless authorized in writing by the BIODCA. Requests for substitution shall be made to the committee at the first reasonable opportunity, which may be after the race.

#### 21. SUPPLIED BOATS

- 21.1. Boats will be supplied by the organizing authority. See Supplied Boats Addendum SB to these sailing instructions.
- 21.2. [DP] Skippers shall submit damage reports to the BIODCA in accordance with Supplied Boats Addendum SB.

## 22. OFFICIAL BOATS

Official RC boats shall be described to competitors at the skippers briefing and will fly a blue or yellow RC flag.

## 23. SUPPORT BOATS

[DP] Support boats, including spectators, shall not be in the racing area from the time of the warning signal until the race has finished or the RC signals a postponement, general recall, or abandonment, unless specifically authorized by the RC as a matter of safety.

## 24. RADIO/TELEPHONE COMMUNICATIONS

[DP] From the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats. This rule shall not apply for purposes of fulfilling requirements outlined in Addendum SB Rule 3.

## 25. TRASH DISPOSAL

Due to COVID-19 trash shall not be placed aboard support or official boats. Trash shall be removed from race boats by competitors each boat swap, and at the end of racing each day.

## 26. BERTHING

[DP] Boats shall be kept in berths in the North dock arm at the RBYC following racing each day.

## 27. RISK STATEMENT

RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.
